SINCE WE DIDN'T HAVE ANY WARNING LIGHTS THERE WAS NOT A LOT THE MECHANICS SAID THEY COULD TROUBLESHOOT. THEY PRETTY MUCH HOOKED UP A MACHINE AND DROVE IT AROUND TOWN. THEIR MACHINE SAID WE GOT 12 TO 13 MPG, STILL NOT WHAT THEY CLAIM IT SHOULD BE GETTING BUT AT THIS POINT I WOULD BE HAPPY WITH THAT! THEY SAID THEY CHECKED THE OIL, FUEL INJECTORS , MADE SURE WE WERE PUTTING THE RIGHT KIND OF GAS IN.
